OFFSHORE SHIPPING RESTRICTIONS AND COMPLIANCE »

Compliance with offshore shipping regulations is critical to avoid potential delays. Some items are strictly prohibited, while others require special handling. Review the following guidelines to keep your shipments moving smoothly.

PROHIBITED ITEMS

- » Hazardous Class 1 (explosives) and Class 7 (radioactive materials)
- » Ammunition
- » Items requiring a license, including diamonds, alcohol and tobacco

TEMPERATURE-CONTROLLED SHIPMENTS

- » Not available for less-than-container-load (LCL) freight
- » Full-container-load (FCL) shipments may be accommodated

SPECIAL RESTRICTIONS AND REQUIREMENTS

Vessel restrictions on hazardous materials vary and product compatibility depends on existing freight. Restrictions are subject to change at any time. Contact the R+L Offshore team with questions regarding shipping hazardous material.

» Over-dimensional or overweight shipments require a quote and booking before transferring to the delivery terminal.

REQUIRED DOCUMENTATION FOR OFFSHORE SHIPMENTS

To ensure timely processing, all documentation must be complete and submitted at time of pickup. Incomplete or missing paperwork may cause delays.

- » All shipping documents must include a valid phone number and email address for the consignee.
- » P.O. box deliveries are not accepted in Hawaii or Puerto Rico.

- » Bill of Lading (BOL): Product description, package dimensions and shipper name matching Commercial Invoice.
- » Commercial Invoice (INV): Must show declared USD value and match the shipper name on BOL.
- » Tax ID (TAX): Consignee's 9-digit tax bond or identification number.
- » Merchant Registration Number (MRN): 11-digit ID assigned to the merchant.
- » Automated Export System (AES): Automated Export System for electronic export filings.
- » Shipper's Export Declaration (SED): Required via AES for shipments over \$2,500 USD.
- » Safety Data Sheet (SDS): For shipments containing hazardous materials.
- » International Maritime Organization Declaration (IMO): For hazardous shipments transported by water.

OFFSHORE PICKUP REQUIREMENTS

When scheduling an offshore pickup, email documentation, including shipper contact information to Offshore@rlc.com.

- » Puerto Rico: BOL, commercial invoice, SED (if shipment exceeds \$2,500 USD), SDS (if hazardous materials) and shipper/consignee contact information.
- » Hawaii and Alaska: BOL, MSDS (if hazardous materials) and shipper contact information.

HAZARDOUS MATERIALS NOTICE

If shipping limited quantity hazardous materials by water, it must be clearly declared on the BOL.
